## Consumers Energy Rebates for New Homes





Builder must work with a Certified Residential Energy Services Network (RESNET) Home Energy Rating System (HERS) Rater in order to participate in the New Home Construction Program. All rebates will be paid to the builder. Qualifying homes must:

 Meet ENERGY STAR® requirements to be eligible for the ENERGY STAR rebate

-OR-

 Meet a HERS Index score of 59 or lower for a standard rebate

Valid for homes completed on or after Jan. 1, 2025

Homes with rough-in inspection dates before Dec. 31, 2024, will receive the 2024 incentives. Homes with rough-in inspection dates on or after Jan. 1, 2025, will receive the updated incentives.
