



HVAC PROGRAM CHANGES: NEW BOILER AND WATER HEATER REBATES

Reminder: Earlier this year, the following incentive changes occurred for natural gas and electric customers:

Boiler* and Water Heater Rebates**

Equipment	Minimum Efficiency	Incentive	Program
Tankless Natural Gas Water Heater	UEF Rated; ENERGY STAR® Certified Model	\$100	MIDSTREAM ONLY
Storage Tank Natural Gas Water Heater	UEF Rated; ENERGY STAR® Certified Model	\$50	MIDSTREAM ONLY
Heat Pump Water Heater	UEF > 2.0; Maximum Capacity of 55 Gallons	\$650	MIDSTREAM ONLY
Natural Gas Boiler	95% AFUE ARHI Rated or Higher	\$800	MIDSTREAM ONLY

*Boiler incentives are no longer be offered through the customer-facing (downstream) incentive delivery channel. Rebates will move exclusively to participating distributors. All residential DTE Natural Gas customers replacing an existing boiler are eligible.

**Eligible water heaters must meet the following efficiency minimums to be eligible for the residential program: Natural Gas Storage Tank Water Heaters: 0.64 UEF, Natural Gas Tankless Water Heaters: 0.81 UEF, Heat Pump (Hybrid) Water Heaters: 2.0 UEF. Any commercial-oriented water heater models are not eligible for the incentives through the residential program. Heat pump water heaters must replace an existing electric water heater.

All incentive changes are effective by *Installation Date* regardless of when the application is submitted.

Boiler and Water Heater Incentive Process Updates:

- Boiler and water heater incentives will be exclusively available

- through Program-participating Distributors (listed below)
- Contractors can purchase program-eligible boilers from participating Distributors at a lower wholesale cost
- Contractors will collect and provide basic product information to their participating Distributor:
 - Model/Serial number, installation date, installation address, and an invoice number from your distributor
- Information can be quickly and easily provided to your participating Distributor via the new Midstream Online Intake Tool (MOIT)
